



Rights and privileges of the different classes of members and for the representatives of Queen's University, other than the rights set out in the Constitution.

**As approved at the Annual General Meeting,
February 07, 2011**

Member organizations are entitled to the following privileges and services in return for payment of an annual fee:

- Attendance by two representatives and one vote for each Member organization at the Annual General Meeting of the Forum.
- Eligibility of a representative for election to the Executive Committee of the Forum.
- Attendance without payment of fees by two representatives at the Forum's conference and special registration fees for additional attendees.
- Attendance without payment of registration fees by one representative at the Forum's retreats. An additional representative or representatives may be approved by the Executive Committee in special cases.
- Access to the Members-Only Section of the Forum's web site at no cost.
- Receive all publications at no cost.
- Priority access to all research and problem-solving services, on cost-recovery basis.

Associates are entitled to the following privileges and services in return for payment of an annual fee:

- Attendance at conferences at special rates.
- Access to the newsletter, at no cost.
- Receive selected publications, at no cost.
- Access at no cost to selected parts of the Members-Only Section of the Forum's web site subject to approval by the Executive Committee.
- Access to support service for information searches, on a fee basis.
- Access to research and problem-solving services, on a fee basis.

Academic Advisors are entitled to the following privileges and services and pay no annual fee:

- Attendance and one vote for each Academic Advisor at the Annual General Meeting of the Forum.
- Eligibility for election to the Executive Committee of the Forum.
- Attendance at Forum retreats without payment of registration fees.
- Attendance at Forum conferences without payment of registration fees.
- Access at no cost to selected parts of the Members-Only Section of the Forum's web site subject to approval by the Executive Committee.
- Receive all publications, at no cost.

Forum Advisors are entitled to the following privileges and services and pay no annual fee:

- Attendance and one vote for each Forum Advisor at the Annual General Meeting of the Forum.
- Eligibility for election to the Executive Committee of the Forum.
- Attendance without payment of registration fees at Forum retreats, subject to approval of the Executive Committee.
- Attendance without payment of registration fees at Forum conferences.
- Access at no cost to selected parts of the Members-Only Section of the Forum's web site subject to approval by the Executive Committee.
- Receive all publications, at no cost.

International Associates are entitled to the following privileges and services, without payment of an annual fee:

- Attendance at conferences at special rates.
- Access to the newsletter, at no cost.
- Receive selected publications, at no cost.
- Access at no cost to selected parts of the Members-Only Section of the Forum's web site subject to approval by the Executive Committee.
- Access to support service for information searches, on a fee basis.
- Access to research and problem-solving services, on a fee basis.

Queen's University is entitled to the following privileges and services and pays no annual fee:

- Attendance and one vote for each representative at the Annual General Meeting of the Forum.
- One representative on the Executive Committee of the Forum.
- Attendance without payment of fees for each representative at the Forum's conference.
- Attendance by two representatives at the Forum's retreats at no cost except travel and accommodation.
- Access at no cost to selected parts of the Members-Only Section of the Forum's web site subject to approval by the Executive Committee.
- Receive all publications at no cost.
- Priority access to all research and problem-solving services, on cost-recovery basis.
